

Word in Action

Disclaimer regarding use of the Word in Action camp grounds, as well as logistical terms and conditions.

- 1) Word in Action cannot be held responsible for any loss of, or damage to property or any injury obtained while visiting the campsite.
- 2) The campsite is booked for the time period agreed upon with management. Any additional stay outside this period must be paid for additionally and must be pre-approved by management.
- 3) The Word in Action campsite only has sleeping facilities for 540 people, meaning only 540 people can be accommodated. Should your numbers exceed this limit, Word in Action can unfortunately not be responsible to support and house the extra people in any way. Where the 540 person limit is exceeded, Word in Action and its management indemnify themselves from any problems that may arise due the camp grounds not being able to handle that many people. This includes sewage, hot water, food quality and food quantity, sleeping arrangements, safety and security, and anything else that can directly or indirectly be related to the excess number of people.
- 4) Please note that the gates will be closed at 23h00, and open up again at 05h00. Access can be gained via the self-phone number provided by your camp organisers, and supplied code for your group. Please make use of these codes. There is no one manning the gate after hours. We would like to make sure everyone on the grounds feel safe at all times and this arrangement is made for your own safety. Please make arrangements if there would be any need for additional safety regulations during your stay.
- 5) No alcohol or drugs is allowed on the grounds. Should you or your guests fail to keep this arrangement we will be forced to end our relationship with you as a client and will we not be able to accommodate you or any annual weekend arrangement that you had with us. It could also lead to non-refund of Deposits paid.
- 6) The swimming pool is a dangerous area. Please note that we do not have any life guards on duty. The risk of the swimming pool lies fully with you as users of the camp grounds. Word in Action make the pool available at own risk during the specific times provided on the gate. (08h00 – 20h00)

- 7) A deposit of at least 10% per stay is required to reserve your weekend for you. In the event of not being able to fulfil your obligation to attend as booked we will reserve the right to withhold your deposit to cover costs. Deposits are not refundable if cancellation is within 60 days from your booked event date.
- 8) Should there be any damages to the grounds after your visit, we reserve the right to claim for such damage from your deposit before deducting deposit from your total invoice amount, or to cancel any of your upcoming or recurring bookings.
- 9) Please note that even though we are in an agricultural area, we do have neighbours that live close to our borders. Please respect our neighbours with whom we have very good relationship. No loud noise will be permitted between 23h00 and 06h00. Please plan your activities in advance to avoid being busy until after 23h00 especially with worship. Your good planning ensures that we stay in good relations with our neighbours.
- 10) Our kitchen closes at 22h00. We cannot after that time serve meals for late comers. Please also understand that we cannot keep food warm for long periods of time. Please stick to your meal times. Please arrange meal times beforehand and keep to your arrangements.
- 11) In the past we allowed some of our group's access to our offices over weekends. Unfortunately we can no longer honour this arrangement due to our office setup that changed recently. We do however leave the toilet and the kitchen open for your leaders to use at their convenience.

We do have other rooms available for private use.

Woord in Aksie

Vrywaring met huur van die Woord in Aksie kamp terrein, asook logistieke reëlins en voorwaardes.

- 1) Woord in Aksie kan nie aanspreeklik gehou word vir enige verlies of skade of beserings opgedoen tydens die besoek op die terrein nie.
- 2) Die terrein word bespreek vir die tydperk wat met bestuur ooreengekom is. Enige verblyf buite hierdie tydperke moet addisioneel betaal word en ook vooraf met bestuur bevestig word vir beskikbaarheid.
- 3) Die Woord in Aksie terrein kan slegs 540 persone slaap. Dit beteken dat ons slegs 540 persone kan akkomodeer. Sou U getalle meer as die 540 perk wees kan ons ongelukkig nie verantwoordelik gehou word om ekstra persone van verblyf te voorsien in watter wyse ookal nie. Waar die 540 perk oorskrei word vrywaar Woord in Aksie en sy bestuur hulself van enige probleme wat mag voorkom in so 'n geval, omdat die terrein homself nie daartoe verleen om soveel mense te kan hanteer nie. Dit sluit in riool, warm water, kos kwaliteit en kos hoeveelheid, slaap gerief, veiligheid en sekuriteit en enige iets anders wat direk of indirek kan verband hou met die oorskreing van getalle.
- 4) Neem asb kennis dat ons die hekke sluit teen 23h00 en weer sal oop maak teen 05h00. Na ure toegang kan verkry word deur die hekkodes te gebruik wat aan U groep deur gegee sal word by arrivering. Daar is nie iemand wat die hek beman na ure nie. Ons wil graag almal wat op die terrein is veilig laat voel te alle tye en hierdie reëling is vir U eie veiligheid. Tref asb reëlins sou daar enige behoefte wees addisioneel in tydperk van U verblyf rondom veiligheid.
- 5) Geen alkohol word op die gronde toegelaat nie. Sou U of U gaste versuim om by hierdie reëling te hou sal ons verplig wees om ons verhouding met U te eindig en kan U dus die naweek wat U jaar op jaar met ons bespreek verloor.
- 6) Die swembad is 'n gevaar area. Neem asb kennis dat ons geen lewens redder aan diens het nie. Die risiko van die swembad is tenvolle op die huurders van ons perseel gelas. Woord in Aksie stel die swembad beskikbaar vir gebruik op eie risiko, binne bepaalde tye soos op hek aangedui. (08h00 – 20h00)

- 7) Ons vereis n deposito van 10% van U beplande totale bywoning. Hierdie deposito sal U naweek vir U reserveer maar Woord in Aksie behou die reg voor om hierdie deposito terug te hou sou U nie die beplande datum kan eer wat U bespreek het nie. Dus sal kansellاسies binne 60 dae van u bespreekte datum veroorsaak dat u deposito verbeur sal word.
- 8) Sou daar enige skade aan die terrein wees na U besoek hou ons ook die reg voor om sulke skade te verhaal van u deposito of as ekstra te laai by u faktuur. Of om U naweek vir die volgende jaar te kanselleer.
- 9) Neem asb kennis dat alhoewel ons in 'n landbou area is, dat ons wel bure het wat naby ons grense bly. Respekteer asb ons bure met wie ons baie goeie verhoudings het die afgelope jare. Geen lawaai of musiek mag gemaak word na 23h00 in die aand tot en met 06h00 in die oggend. Beplan vooruit om U program so aan te pas om te verhoed dat U nog besig is met verrigtinge veral lofprysing teen 23h00. Goeie beplanning verseker dat ons in goeie verhouding bly met ons bure.
- 10) Reël asb vooraf met die kombuis vir etens tye. Ons kan nie die kombuis onbepaald oop hou vir etes of vir laat kommers nie. Ons kombuis sluit in die aand 22h00. Daarna sal geen etes meer bedien word nie.
- 11) In die verlede het ons van ons kantore beskikbaar gemaak aan van ons besoekers. Ons kan egter as gevolg van sekerheid nie langer hierdie reëling volhou nie. Ons kantore sal gesluit wees oor naweke wat u besoek. Ons los wel die kombuisie en die toilet oop vir gebruik deur u leiers gedurende die naweek. Ons kleingroep lokaal en gebedshut is beskikbaar vir privaat behoeftes.
